Voting plan B, the current voting plan for USD No. 386, permits all qualified electors who reside in a particular member district to vote in the primary election for the member positions of such member district and for the at-large member position, and further permits all electors who are otherwise qualified according to law, and who reside in the school district, to vote in the general election for all member positions, including the at-large member position, to be filled.

Voting Plan A, the plan that the district proposes be adopted, would permit all electors who are otherwise qualified according to law and who reside in the school district to vote in both the primary and general election for all member positions.

To vote in favor of changing the voting plan for election of USD 386 school board members from Voting Plan B to Voting Plan A, select the word "YES."
