

The Board of Woodson County Commissioners met in a regular business session on January 12th, 2021 at 8:30 a.m. with Chairman Monty Barnett, Vice-Chairman Wayne Faulkner, Member Justin Clark, County Attorney Schlotterbeck and County Clerk Tesla Bayles.

The Pledge of Allegiance was recited.

Justin Clark made the motion to nominate Monty Barnett as Chairmen, Wayne Faulkner second the motion.

Monty Barnett made the motion to nominate Wayne Faulkner as Vice Chairman, Justin Clark second the motion.

Wayne Faulkner made the motion to approve the agenda. Justin Clark second the motion.

Attorney Zelda Schlotterbeck presented memos to the newly elected officials explaining executive session for attorney client privileges and executive sessions for non-elected personnel.

John Weseloh met with the board asking the Board to give permission to remain designee to the juvenile Justice and Regional Planning committee. Faulkner made the motion to approve Weseloh to remain on the committees. Clark second the motion, with Barnett making it unanimous.

Emergency Preparedness director met with the board to discuss the Family First Coronavirus Response Act has expired as of December 31st, 2020. Discussion was held and will be revisited next week. Bartley reported he repaired radios for Dispatch and an Ambulance Department.

Public Works Administrator presented his weekly reports and discussed hauling rock South of Toronto.

Sheriff Jeffery McCullough met with the board to discuss changing overtime for Deputies. Faulkner made the motion to allow McCullough to change overtime to anything over 40 hours a week is overtime for Deputies. Justin second the motion, with Barnett making it unanimous. McCullough requested to change holiday hours to match courthouse holidays. Clark made the motion to make Sheriff holidays the same as courthouse. Faulkner second it, with Barnett making it unanimous.

Faulkner moved to resend resolution 20-17. Clark second it, Barnett voted no. Motion passed.

Clark made the motion to enter executive session for non-elected personnel to protect employee confidentiality; to discuss employee performance for 10 minutes with the Board, County Attorney, County Clerk starting at 10:06 a.m. and reconvened at 10:16 a.m., in the courtroom Faulkner second it, with Barnett making it unanimous.

Dale Stapleford had discussion with the board regarding county road condition in the county. Justin Clark explained the Road and Bridge Complaint policy and maintenance process.

Clark moved to enter into executive session for non-elected personnel for 15 minutes with the Board, County Attorney and County Clerk starting at 10:41 a.m. and reconvened at 10:56 a.m., in the courtroom Faulkner second it, with Barnett making it unanimous.


The meeting was adjourned at 11:02 a.m.




