

The Board of Woodson County Commissioners met in a regular business session on June 14th, 2022 with Chairman Justin Clark, Vice-Chairman Wayne Faulkner, Member Monty Barnett, County Attorney Zelda Schlotterbeck and County Clerk Tesla Bayles.

The Pledge of Allegiance was recited.

Faulkner made the motion to approve the June 14th, 2022 agenda. Barnett seconded it, with Clark making it unanimous.

Faulkner made the motion to approve the minutes from June 7th, 2022. Barnett seconded it, with Clark making it unanimous.

Discussion was held on the Neighborhood Revitalization Plan and the interlocal agreements.

Jeff McCullough stated that the Sheriff's Office is having internet connection issues. The board suggested that he call Cox and Advantage Computers to troubleshoot the issue.

Jarrod McVey presented bids for a grounding system from K-J Electrical. The board requested he obtain 2 more bids. McVey presented a quote for an individual to paint the appraisers Office since it suffered water damage. The Board asked for 2 more quotes.

Clark made the motion to approve resolution 22-13 A Resolution Concerning the Salary and Compensation of Election Board Workers of Woodson County. Faulkner seconded it, with Barnett making it unanimous.

Clark made the motion to appoint Judy Laws and Mark Pringle as the two electors to supervise the Clerks office destruction of 8-4-2020 primary ballots. Faulkner seconded it, with Barnett making it unanimous.

EMS Director Cari Cavender presented a wage sheet for a new employee. Faulkner made the motion to approve the wage sheet for Brian Siedschlag as part-time PRN On Call Medic. Barnett seconded it, with Clark making it unanimous.

Mike Fitzgerald came to the board to discuss Neosho Valley Senior Center 2023 budget request. A 10 percent increase is need to accommodate inflation.

The head of the Toronto Senior Center came to the board to discuss the 2023 budget request.

Yates Center Senior Center came to the board to discuss the 2023 budget request.

Kurt Jackson with KJ Electrical came to the board to explain his quote for the ground wire system. He will check with the engineer to see if the roof has to be replaced before the ground system can be installed.

Ron Shaffer with the Woodson County Historical Society came to the board to discuss his 2023 budget request. The board inquired on the cost to get the old county jail cleaned. The old county jail was painted with led paint. It would cost over \$25,000 to remove. Shaffer informed the board of the Historical Society Expenditures. Shaffer asked the board how to get internet at their building. It was suggested to call Quitcom, AT&T or check out the hot spot from the County Clerk. Shaffer will check out the hotspot.

Cindy Lane and Cathy Brett from the SEK Area on Aging came to the board to discuss their budget request. Area on Aging does pay the Yates Center Senior Center 10 dollars per one way trip to transport seniors around Yates Center. They also provide assistance for people who are needing to sign up with Medicare.

Chari Bauman with the Woodson County Chamber came to the board to discuss the 2023 budget request. Bauman is requesting \$39,000 for 2023. The board agreed to \$35,000.

Conservation District members came to the board to discuss 2023 budget request.

Faulkner moved to recess for a 5-minute break from 11:40 a.m. to until 11:45 a.m.

Woodson County Health Department came to the board to discuss 2023 budget request.

John Weseloh with the Fair Association came to the board to discuss the 2023 budget request.


Bill Fiscus CEO of Tri-Valley presented to the board the 2023 budget request.

Barnett made the motion to appoint Jeff McCullough to the SEK Homeland Security Council. Faulkner seconded it, with Clark making it unanimous.


Clark made the motion to pay vouchers in the amount of \$69,190.02. Faulkner seconded, with Barnett making it unanimous.

Faulkner made the motion to adjourn at 12:55 p.m. Clark seconded it, with Barnett making it unanimous.




