The Pledge of Allegiance was recited.

Faulkner made the motion to approve the agenda. Barnett seconded it, with Clark making it unanimous.

Faulkner made the motion to approve the minutes from June 21st, 2022. Barnett seconded it, with Clark making it unanimous.

The Attorney informed the board that a Woodson County citizen opened the door on a grader last week while it was in operation and proceeded to be disorderly towards a county employee. Charges are going to be filed.

Faulkner made the motion to approve the bid for Advantage Computers for \$57,517.00 to be taken out of ARPA or Courthouse Equipment Reserve. Clark Seconded it, with Barnett making it unanimous. Faulkner made the motion to approve the quote for Kansas Communication Services to do the phone wiring for District Court for \$737.38. Barnett seconded it, with Clark making it unanimous.

Dillon Boren with Boren's Roofing came to the board to answer questions about his quote.

Faulkner moved to take a 5 min break. Clark seconded.

Barnett made the motion to pass Resolution 22-14 amending Resolution 99-04. Resolution 22-14 will allow the sharing of paid time off among county employees. Faulkner seconded it, with Clark making it unanimous.

Faulkner made the motion to pay vouchers for \$6,223.21. Barnett seconded it, with Clark making it unanimous.
