

The Board of Woodson County Commissioners met in a regular business session on August 25th, 2020 at 8:30 a.m. with Chairman Forsyth, Vice Chairman Yoho, Member Barnett, County Attorney Schlotterbeck, and County Clerk Porter.

The Pledge of Allegiance was recited by Forsyth, Yoho, Barnett, Schlotterbeck and Porter.

Barnett moved to approve the agenda as amended. Yoho seconded the motion with Forsyth making it unanimous.

Barnett moved to approve the August 18th minutes. Yoho seconded the motion with Forsyth making it unanimous.

Barnett made the motion to accept wage sheet on two new employees as ambulance drivers for the EMS Department. Yoho seconded the motion with Forsyth making it unanimous.

Public Works Administrator Onnen presented weekly reports. Onnen explained the bridge on Apache is completed. Onnen also discussed the county road conditions.

Barnett made the motion to accept Resolution #20-13, a resolution authorizing submission of the question on the general election ballot; the continuation of a one percent (1.0%) countywide retailers' sales tax to the qualified electors of Woodson County, Kansas to provide property tax relief for the citizens of Woodson County, Kansas. Yoho seconded the motion with Forsyth making it unanimous.

Kansas Department of Revenue sent memorandum to Chairman Forsyth regarding his request from the Division of Property Valuation; audit of property.

J.J. Edwards representing Revitalization Organization brought the Board up to date on the organization, and the goals for the near future.

Barnett made the motion for the chairman to sign the land and tower purchase contract with Haas Oil Company on contingent of the guide wires/anchors comply with specifications.

Barnett moved to approve all Board members to sign the District #10 Transportation letter. Yoho seconded the motion with Forsyth making it unanimous.

Garrett Eggers declining his write in on the General election ballot for Perry Township, based upon his current position as the County Clerk seat. Barnett made a motion to accept the declination by Garrett Eggers, Yoho seconded the motion with Forsyth making it unanimous.

Barnett moves we recess into executive session to discuss attorney/client privileges for 10 minutes with the Commissioners, County Attorney, at 10:04 a.m.; reconvene at 10:14 a.m.

in the Commissioners meeting room. Yoho seconded the motion with Forsyth making it unanimous.

Barnett made the motion to approve the checks and vouchers to be paid for the amount of \$320,316.17. Yoho seconded the motion with Forsyth making it unanimous.

Meeting was adjourned at 10:49 a.m.


