Faulkner declined to be present.

Sedlacek motioned to accept wage increase for GIS Diane Ludwig from \$15.50 to \$18.00. Requested by Appraiser Mentzer and approved by Commissioners. Clark seconded with Faulkner making it unanimous.

Faulkner made the motion to pay vouchers for \$17,274.43. Sedlacek seconded with Clark making it unanimous.
