RESOLUTION NUMBER 07-12

A RESOLUTION FOR PARTICIPATION IN THE NATIONAL FLOOD INSURANCE PROGRAM

- WHEREAS; Certain areas of Woodson County are subject to periodic flooding causing serious damages to properties within these areas, and;
- WHEREAS; Relief is available in the form of Federally subsidized flood insurance as authorized by the National Flood Insurance Act of 1968, and;
- WHEREAS; It is the intent of this County Commission to require recognition and evaluation of flood hazards in all official actions relating to land use in areas having these hazards, and;
- WHEREAS; This body has the legal authority to adopt land use and control measures to reduce future flood losses pursuant to KSA 12-766 (State Statute).


NOW THEREFORE BE IT RESOLVED: That the Governing Body of Woodson County, Kansas hereby:

1. Assures the Federal Insurance Administration that it will enact as necessary, and maintain in force in those areas having flood hazards, adequate land use and control measures with effective enforcement provisions consistent with the Criteria set forth in Section 60.3 of the Nation Flood Insurance Program regulations; and
2. Vests Jerry Mentzer, <sup>Zoning Administrator</sup> (Official, Office or Agency) with responsibility, authority, and means to:
  - a. Assist the Federal Insurance Administrator, at his/her request, in delineating the limits of the areas having special flood hazards;
  - b. Provide such information as the Administrator may request concerning present uses and occupancy the floodplain areas;
  - c. Cooperate with Federal, State, and local agencies and private firms with undertake to study, survey, map, and identify floodplain areas in order to prevent aggravation of existing hazards;
  - d. When received from the Administrator, complete and submit those reports which advise the Administrator on the progress made within the community in the development and implementation of floodplain management measures;
  - e. Upon occurrence, notify the Administrator in writing whenever the boundaries of the community have been modified by annexation or loss of authority to adopt and enforce floodplain management regulations for a

particular area. Included in such notification will be a map of the community, suitable for reproduction, which clearly delineates the new corporate limits or new area for which the community has assumed or relinquished floodplain management regulatory authority.

3. Appoints Jerry Mentzer <sup>Zoning Administrator</sup> (Official, Office or Agency) to maintain for public inspection and to furnish upon request, for the determination of applicable flood insurance risk premium rates any certificates of floodproofing and information on the elevation (in relation to mean sea level) of the lowest floor (including basement) of all new or substantially improved structures; and
4. Agrees to take such other official action as may be reasonably necessary to carry out the objectives of the Program.
